Ficalora, founder and acting supervisor of the Montauk Friends of Olmsted Parks/Montauk Trustee Corporation and of the Town of Montauk does herewith swear under the pains and penalties of perjury upon the attached **Notice and Demand** dated April 21st, 2011, and the requested **Executive Order** that:

This affidavit is made upon the full record of the original signed copies of the **Certificate of Incorporation of the Town of Montauk** and a **Certificate of Merger of the Montauk Friends of Olmsted Parks and the trustees of Montauk corporations** filed on July 26th, 2010 with the Division of Corporations of the Department of State of the State of New York but that were rejected by letter dated August 11th, 2010 on the basis that **"there are no provisions providing for the formation of a town under the Business Corporations Law."** The signature-bearing copies were served upon Governor Paterson (with copies to Governor Andrew Cuomo while serving as Attorney General) remain at the Governor's office for presentation and filing.
